- LaFSA organization is moving forward with no charge for membership (Free to all UTA employees), effective 2024-2025.
- LaFSA Board will work on donation tiers, marketing and communication plans.
- If we decide to move forward with Donation/Sponsorship tiers, then LaFSA will need to rewrite the sections in the constitution and bylaws for change and approval. Need votes by membership into bylaws
